



PUPPY SALES CONTRACT AND AGREEMENT

Triple M Kennels is dedicated to the improvement of the German Shorthaired Pointer. The intent of this contract is to assure Puppy Buyers that the puppies produced from this kennel are not from indiscriminate breeding, but careful thought to enhance the outstanding hunting qualities and health of the breed.

Triple M Kennels will notify Puppy Buyer within three days of birth of the litter at which deposit(\$250) is due.

Puppy Pick Out Day will be the Saturday after puppies turn 4 weeks old. Puppies are picked in order of deposit on the day of Puppy Pick Out Day.

Puppy Send Home Day will be the Saturday after the puppies turn 8 weeks old (unless notified otherwise).

Puppy Buyer agrees to pick up their puppy on above send home date. If the puppy cannot be picked up on that date a boarding fee of \$25 a day will be due upon pick up of the puppy.

Triple M Kennels does not ship puppies. Puppy Buyer must pick up their puppy from Triple M Kennels. If Puppy Buyer decides to ship the puppy then Triple M Kennels does not accept responsibility for any health issues aside from genetic issues that may arise.

HEALTH GUARANTEES

Triple M Kennels certifies that, upon Puppy Buyer's receipt, the puppy is in good health and has been given their first set of vaccinations, has been wormed and has had a health check by a licensed veterinarian. Triple M Kennels will provide health and vaccination records to Puppy Buyer.

- Worming: 2 wks, 4wks, 6wks, and 8wks
- Vaccinations: 6wks & 8wks

Puppy Buyer can return the puppy at Puppy Buyer's expense for a full refund if it develops an illness within 72hrs puppy of being picked up. Puppy Buyer must notify Triple M Kennels immediately following diagnosis. Documentation must be provided by Puppy Buyer's veterinarian and will be reviewed by Triple M Kennel's veterinarian for concurrence. Puppy Buyer must return the puppy within 24 hours of notifying Triple M Kennels of the puppy's illness with all registration paperwork and health records at Puppy Buyer's expense. Triple M Kennels will not reimburse veterinary or shipping costs.

Triple M Kennels does not accept responsibility for contagious diseases diagnosed after three days from date of pick up. If during examination by Puppy Buyer's veterinarian a genetic issue is found and documented in writing by the examining veterinarian, the puppy may also be returned at Puppy Buyer's expense for a full refund. If the genetic issue can be repaired and Puppy Buyer wishes to do so, Triple M Kennels will reimburse Puppy Buyer up to the cost of the puppy. Any additional expenses will be the sole responsibility of Puppy Buyer.

Should any circumstances arise that affect the quality of life of the puppy Triple M Kennels is to be informed so they may participate in determining the future of the puppy.

This guarantee does NOT cover conditions that are a result of negligence and/or abuse of the puppy.

RESPONSIBILITIES OF TRIPLE M KENNELS

Triple M Kennels agrees to:

- Register the puppy with Limited AKC registration at Buyers Expense (Puppy's registration name must have the prefix "Triple M")
- Dock the puppy's tail
- Administer first set of vaccinations and worming for the puppy

RESPONSIBILITIES OF PUPPY BUYER

Puppy Buyer agrees to:

- Come to puppy send home with a registered name picked out including the prefix "Triple M"

Registered name is/will be _____

- Provide the puppy with a loving home where the puppy will live in the house as part of the family
- socialize, train, and keep the puppy in a manner acceptable to Triple M Kennels
- Maintain the puppy in good health as recommended by a veterinarian. Puppy Buyer shall provide all proper immunizations, regular vaccine boosters, fecal exams, heartworm tests, and recommended routine therapy
- Will not spay or neuter the puppy until it is a minimum of 6 months old, if so desired

Puppies sold on limited registration may not be shown in AKC conformation shows or bred.

BREEDING

If, Puppy Buyer wishes to breed their puppy all breedings will be facilitated through Triple M Kennels. The decision will be made together whether to breed the dog and who to breed to the dog. Prior to the breeding taking place Triple M will lift the limited registrations and will lease the damn from Puppy Buyer. Triple M Kennels will facilitate the stud services or will whelp and raise the litter of puppies. Individual breeding contracts will be created on an individual basis. Don't hesitate to ask for more information.

Males: • Puppy Buyer will receive compensation for stud services equal to the purchase price of a puppy or pick of the litter.

Females: • Puppy Buyer will receive compensation for leased dam equal to the purchase price of a puppy or pick of the litter.

REHOMING

If, for any reason, Puppy Buyer can no longer care for the puppy, Triple M Kennels must be notified and given the first opportunity to resume ownership, however Triple M Kennels is not required to accept the puppy. The puppy may not be transferred or sold by the Puppy Buyer unless notified. If Triple M Kennels resumes ownership the puppy will be returned with all of its registration paperwork and health records.

Under no circumstances will the puppy be sold, leased, traded or given away to any breeder, kennel, pet shop, research laboratory, animal shelter or similar facility. Doing so Puppy Buyer will be responsible for a fee of \$5000 plus any legal or recovery costs associated with the return of the puppy to Triple M Kennels.

Puppy Buyer agrees to allow Triple M Kennels access to the puppy, and to the premises where it is kept, to evaluate the condition therein. If Triple M Kennels determines, by any means, that the puppy is not suitably cared for, or that it has been mentally or physically mistreated, Triple M Kennels has the right to take full possession of the dog, and its AKC transfer papers/registration, without compensation.

Triple M Kennels opinion is the only authority required to justify this action. Testimony of other people will not supersede Triple M Kennels judgment on this matter. Under such circumstances, all warranties are then VOID.

Puppy Buyer agrees not to sue Triple M Kennels and to pay any and all court or attorney fees incurred by Triple M Kennels should any suit be brought against the seller regarding this puppy by any person.

RELEASE

Triple M Kennels is hereby released from any and all future liability to Puppy Buyer with regard to the puppy. Puppy Buyer agrees that from the date they take possession of the puppy, Puppy Buyer accepts all liability for the actions of the puppy and holds Triple M Kennels harmless with regard to any and all third parties. No other warranties or guarantees, expressed or implied, are made under this contract except as stated herein.
